HENDRICKS COUNTY UTILITY ASSISTANCE

Energy Assistance Program is taking new applications. You may qualify to receive federal funding to help pay some of your bills this winter! The Energy Assistance Program (EAP) is a federally funded program to help Indiana residents pay their utility bills and prevent utility shut offs.

Households that earn less than 60% of the state median income (60 SMI) may qualify to receive this benefit. The online application is open from **October 1, 2024 to April 14, 2025 at 5:00 PM EST**. Qualified households will be protected by the energy moratorium, which prevents their heat and energy utilities from being shut off in the winter months.

The documents you will need to get the assistance a **copy of your photo ID, Social security cards for all household members, proof of income, copy of lease, and copy of utilities bills.**

Emergency Rental Assistance (ERA)

Helps renter households with rent and utility assistance. This includes help with paying rent up to 18 months of current and past- due rent. This assistance is through Community Action of Greater Indianapolis. **ERA is accepting applications until funds run out.**

When you call, dial “1” for English and then “0” to speak with an operator. Once the operator answers you say, “Hendricks County” and then “trying to apply for ERA”.
